

ORDINANCE NO. 2018-01

ORDINANCE PROVIDING FOR THE ABATEMENT OF PORTIONS OF THE YEAR 2017 TAX LEVY OF THE LAKE VILLA FIRE PROTECTION DISTRICT, LAKE COUNTY, ILLINOIS

WHEREAS, the Board of Trustees of the Lake Villa Fire Protection District, Lake County, Illinois, by Ordinance 2017-02 provided for the levy of a direct annual tax in the amount of \$5,695,806.00 distributed between certain funds as follows: 1) Corporate Fund - \$2,751,837.00; 2) Ambulance Fund - \$1,723,701.00; 3) Firefighter Pension Fund - \$100.00; 4) Social Security Insurance Program Fund - \$84,746.00; 5) Medicare Program Fund - \$49,240.00; 6) Tort Immunity Fund - \$57,946.00; and, 7) Audit Fun - \$100.00; and

WHEREAS, the Lake Villa Fire Protection District will have sufficient funds on hand available for the purpose of paying corporate and ambulance fund expenses; and

WHEREAS, it is necessary and in the best interests of the Lake-Villa Fire Protection District that a portion of such taxes heretofore levied for the year 2017 be abated:

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Lake Villa Fire Protection District, Lake County, Illinois, as follows:

Section 1 Abatement of Tax:

A. The tax heretofore levied for the year 2017, payable in 2018, in Ordinance No. 2017-02 for the Corporate Fund is hereby abated in the amount of \$2,500,000.00 and the remainder of such levy in the amount of \$251,837.00 shall be extended in its entirety.

B. The tax heretofore levied for the year 2017, payable in 2018, in Ordinance No. 2017-02 for the Ambulance Fund is hereby abated in the amount of \$2,500,000.00 and the remainder of such levy in the amount of \$251,837.00 shall be extended in its entirety.

C. All other taxes levied for the year 2017, payable in 2018, in Ordinance No. 2017-02 shall be extended in the amounts stated in that Ordinance No. 2017-02.

Section 2: Upon the adoption of this ordinance, the Secretary of the Board, assisted by the District's Attorney as may be appropriate, shall file a copy hereof with the County Clerk of Lake County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2017 in accordance with the provisions hereof.

Section 3: That the invalidity of any item or Section of this Ordinance shall not affect the validity of the whole or any other part hereof.


