

ORDINANCE NO. 2017 - 02

ORDINANCE LEVYING AND ASSESSING TAXES OF
LAKE VILLA FIRE PROTECTION DISTRICT
LAKE COUNTY FOR 2017

BE IT ORDAINED by the Board of Trustees of the Lake Villa Fire Protection District as follows:

Section One: That the sum of FIVE MILLION SIX HUNDRED NINETY-FIVE THOUSAND EIGHT HUNDRED SIX AND NO/100TH DOLLARS (\$5,695,806.00) be assessed and levied from and against all taxable property within the limits of the said Lake Villa Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2017. The specific amount hereby levied for each object and purpose is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

AMOUNT TO BE RAISED BY TAX LEVY:

CORPORATE FUND

Corporate Fund Levy \$2,751,837.00

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

AMBULANCE FUND

Ambulance Fund Levy \$2,751,837.00

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

FIREFIGHTER PENSION FUND

Firefighters' Pension Fund Levy \$100.00

The foregoing amount is hereby levied for firefighter pension fund purposes pursuant to the provisions of 40 ILCS 5/4-118.

[Including Amount Exempt from PTELL Pursuant to P.A. 93-0689 \$0.00]

SOCIAL SECURITY INSURANCE PROGRAM FUND

Social Security Insurance Program Fund Levy \$84,746.00

The foregoing amount is hereby levied for Social Security Insurance Program purposes pursuant to the provisions of 40 ILCS 5/21-110.

MEDICARE PROGRAM FUND

Medicare Program Fund Levy \$49,240.00

The foregoing amount is hereby levied for Medicare Program purposes pursuant to the provisions of 40 ILCS 5/21-110.1.

TORT IMMUNITY FUND

Tort Immunity Fund Levy \$57,946.00

The foregoing amount is hereby levied for tort immunity purposes pursuant to the provisions of 745 ILCS 10/9-107.

AUDIT FUND

Audit Fund Levy \$100.00

The foregoing amount is hereby levied for audit expense purposes pursuant to the provisions of 50 ILCS 310/9.

Section Three: If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of remaining portions of the Ordinance.


Section Four: That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.


